Free School Meals

Free School Meals awarded as a result of a parent's application on income grounds. Free school meals are not the same as Universal School Meals and should be applied for separately.

A child registered for Free School Meals not only gives the school additional money to buy equipment and fund more teaching staff but also benefits you as there are concessions for trips and swimming that may be granted by the Headteacher.

Your child may be eligible for Free School Meals if you receive one of these benefits:

- Income support
- Income based job seekers Allowance
- Child Tax Credit (not including Working Tax Credit) – please check The Government website for amount the household income is eligible for
- Guaranteed Element of the State Pension Credit
- An income-related Employment and Support Allowance
- Support under part V1 of the Immigration and Asylum Act 1999 if you are an asylum seeker
